SERVICES ARE AVAILABLE AT CLINICS IN LONGMONT AND BOULDER, CO ALTHOUGH WE DO CARE FOR PATIENTS FROM VARIOUS AREAS IN THE STATE AND THE COUNTRY. WOMEN'S HEALTH ASSURES THAT ALL PATIENTS CAN RECEIVE THE HEALTH CARE THEY NEED REGARDLESS OF INCOME OR INSURANCE COVERAGE.
